First full year of data shows clear TCAM progress
Activity data for the first full year of the pathway, which enables hospital trusts to send secure online messages to community pharmacists to identify patients in need of extra help with their medicines after leaving hospital, clearly show a drop in activity as the Covid-19 pandemic took hold in April.
