Changes to Terms of Service	Contractual Requirement	Postponed till Autumn 2020	HLP was meant to be essential service as part of the Community Pharmacy Contractual Framework from 1 <sup>st</sup> July 2020 and all Contractors were required to be HLP Level 1 as part of their Terms of Service. Public health campaigns	Contractual Requirement	Begins in Early October ( look out for further info )	Community pharmacies will need to participate in two health campaigns during the rest of 2020/21, the first of which will be the annual campaign which encourages eligible people to get vaccinated against flu. This campaign will begin in early October with campaign resources being delivered to. More information can be found <u>here.</u>	
PQS Aspiration Claim Payment Window open	Pharmacy Income	Open till 23:59 on 9 <sup>th</sup> October 2020	The Aspiration payment window for the Pharmacy Quality Scheme 2020/21 Part 2 is now open. Contractors who wish to, can claim an Aspiration payment for this scheme, to assist with cash flow can claim via <u>Manage Your</u> <u>Service (MYS) portal</u> . The Aspiration payment is optional. To qualify to receive it, contractors will need to decide which domains they intend to meet at the February 2021 declaration period and declare that they will complete PQS Part 1 by 23:59 on 29th January 2021. Pharmacy Quality Scheme (PQS) 2020/21: Part 1	Pharmacy Income	By 23:59 on the 29 <sup>th</sup> January 2021	<ul> <li>To meet the requirements of the new scheme, contractors need to complete all 14 actions set out in a checklist, all of which relate to the response to the pandemic.</li> <li>Download the Part 1 PQS 2020/21 Checklist for the COVID-19 response</li> <li>advice on what evidence should be retained to demonstrate that contractors have complied with the scheme.</li> <li>answers to frequently asked questions on the scheme;</li> <li>a PSNC 10-minute digital guide to the scheme; and</li> <li>a record sheet to capture staff briefings, or training sessions.</li> </ul>	

			<ul> <li>Local information you will need for PQS         <ul> <li>Criteria 5:: Along with the national testing programme there is support locally for testing which can be found <u>here</u>.</li> <li>Criteria 8: Local information for updating your Business Continuity Plan can be found <u>here</u>.</li> </ul> </li> <li>Up until 5th September 2020, just over 6,000 contractors had submitted a claim for the Part 1 scheme to the NHSBSA, meaning that around 5,000 contractors have still to do so. We recommend to complete this ASAP.</li> </ul>
