LPC news

Only hours to the deadline yet only 30% of contractors in Surrey and Sussex have claimed for help with cash flow Data shared last week with the LPC by NHS BSA showed that 71% of contractors had not claimed for their aspiration payment. The letter highlights the joint incentives available to both for working together, promotion of immunisation services, local notification arrangements and immunisation in residential and care homes

New patient info explains the wait for flu vaccinations

If you haven't seen it already, there is a new page with information concerning flu vaccine supplies on GOV.UK <u>Flu vaccination: why you are being</u> <u>asked to wait</u> which includes <u>this leaflet for you to use with patients</u> if it helps you with, what could be, difficult conversations.

LPC negotiates £100K worth of flu services for council staff

This year we're working with Surrey County Council and Brighton & Hove City Council to vaccinate up to 7,000 of their staff under two new locally commissioned service agreements worth around £100,000 income across Surrey and Sussex. The service in Brighton and Hove started this week on 5 October with 18 community pharmacies signing up to provide the service.

Potential changes to wound care supplies at NHS Surrey CCG

NHS Surrey CCG has started a review of the existing off-prescription arrangements, which could see the supply of dressings via ONPOS shifted away from community pharmacy. We have secured protections for the supplies already via FP10 prescription to be retained via this route.

The LPC has encouraged the CCG to consult with the 80 local pharmacies involved in the service. Participating pharmacies received a letter by email direct from the CCG to pharmacy premises email address on Friday 11 September 2020 around 2.50pm. We would urge you to respond to

Blister packs / Dossette boxes / MCA
