Ramiz Bahnam has stepped down from East Sussex LPC. Ramiz had been a committee member since March 2014, one of nine members who has helped to shape the direction of the LPC and represented the LPC on the Area Prescribing Committee. There is now a vacancy on the committee for an independent contractor representative in East Sussex, Brighton and Hove to serve for the rest of the LPC term to March 2022. Community pharmacy primary care network (PCN) leads meet to discuss local elements of the Pharmacy Quality Scheme (PQS)

It was as good as a full-house last week when 35 out of 45 current community pharmacy PCN leads met online to learn more about their role co-ordinating PQS participating contractors in their network. They will now be reaching out to all pharmacies in their PCN to deliver local collaborative work to meet domains 4 and 5 of the Pharmacy Quality Scheme part 2.

 There's around 15 PCN areas across Surrey and Sussex without a current PCN lead. We are helping these areas local areas to fill the vacancies. <u>Check if you have a lead in your local area.</u> If not, can you, or a colleague, step up to ensure all pharmacies in your area can meet the PQS requirements?

Supporting patients in West Sussex coming out of hospital

West Sussex is about to join TCAM, connecting pharmacy with secondary care and primary care, with referrals commencing from Western Sussex Hospital sites of St Richard's and Worthing from 16 November 2020. TCAM has many benefits, including improving the safety of dispensing and being able to positively challenge prescribing. But more than that, it's critical to deliver the new Discharge Medicines Service, a new essential service being added to the CPCF from 1st January 2021.

- Contractors in West Sussex should now look-out for one or two referrals a week coming through PharmOutcomes from mid – late November.

GP Referrals into the Community Pharmacist Consultation Service

From 1 November 2020 it became possible for GPs to be able to refer patients into the CPCS service for minor illness consultations. Local preparatory work to mobilise the service is just beginning, and includes GPs, PCNs, CCGs and the NHS England & Improvement region working together with all the LPCs in the South East region to agree how this will work.

The plan, so far, is for phased implementation over the next six months, with further information becoming available at short notice as discussions progress. The first phase, beginning shortly, will be NHSE&I seeking expressions of interest from GP practices & PCNs who wish to be early adopters for a roll out in the New Year.

the latest Government messaging (staying alert to symptoms and don't enter if you have symptoms). Please try to avoid using previously issued posters, or those you have produced yourself. We are also aware of a <u>poster created by the Royal Pharmaceutical Society</u>.

Helping to reduce the number of calls you receive into pharmacy We are hearing from contractors that pharmacy phones are 'red-hot' so are doing what we can to help reduce the number of incoming telephone calls by encouraging our stakeholders and system partners to amplify and pass on <u>our</u> <u>public messaging</u> to help you. It is hoped that consistent messaging across local heath and civic partners will help manage citizen's expectations of community pharmacy during lockdown and help keep pharmacy staff safe.
