

# PQS (pharmacy quality scheme) Support for contractors

Support for NHS community pharmacy contractors in Surrey and Sussex

Local guidance for ALL contractors who want to claim for Part 2 PQS 20/21
Surrey and Sussex | 17 February 2021

Over 50% of Pharmacies across the Surrey and Sussex have already submitted their claim – across each LPC that's 60% of pharmacies in West Sussex, 64% in East Sussex , and 42% in Surrey.

With one week to go there is still time to claim payment via MYS for any of the five domains where you have met all specified criteria. Please don't leave it until the last minute.

 PSNC have produced additional FAQs regarding the flexibility to timings announced by NHS England and NHS Improvement (NHSE&I) and the Department of Health and Social Care (DHSC). Flexibility does not apply to all domains and in particular Domain 5 business continuity, the extension to June allows for collation of evidence. The contractor discussion must be held before the declaration period of 1st March. Read more
