Surrey Chlamydia service – Focus target area for Women

Surrey Public Health have launched a campaign which focuses on identifying opportunities to screen women for chlamydia. Please note men can still access the service and should be encouraged to get tested, there is no change to the service specification. The focus amongst women is led by the increasing harm that undiagnosed chlamydia infection can cause and if left untreated, it can spread to the womb and cause a serious condition called pelvic inflammatory disease (PID). As part of this initiative please offer chlamydia testing to all eligible women within your service specification inclusion criteria and eligible patients that request EHC, contraceptive medication, purchase condoms or ask for advice where chlamydia testing could be offered. Any patients who do not meet the criteria for the service please signpost to the online home screening kit order form link here.

Sussex Assisted LFT commissioned service

A pharmacy poster to display will be sent to stores over the coming week to be used to promote the service. The aim is to increase awareness and highlight the service to patients visiting the pharmacies. This can be displayed on HLP board.

Brighton HLP Pharmacies – Weight Management Referrals

As part of the locally commissioned service Healthy Living Pharmacy in Brighton weight management referrals has been introduced with two different payments:

- The targeted payment is £10 for referrals made on behalf of someone from a Black, Asian, or ethnic minority
- The standard payment is £5 for all other referrals

The reason for the differential payment is supported by the PHE Excess Weight and COVID-19 report published in July last year which details evidence-based insights on the

relationship between excess weight and COVID-19. Excess weight affects all population groups but is higher for some Black, Asian, and Minority Ethnic (BAME) groups compared with the general population. It is established that the health risk of excess weight for some BAME groups occur at a lower BMI than for White populations. **Did you know....** this incentivised HLP scheme also supports the PQS 2021/22 Healthy Living Support Domain. This will allow pharmacies to claim the maximum points available for this domain as well as payment under the HLP service.

Weight Management

To support the healthy living domain, we have produced a document that includes all local authority tier 2 weight management programs and the national referral routes.

Pharmacy teams must proactively discuss weight management with a minimum of 25 patients for the intervention element and refer 1 patient into the national weight management program or into a local authority tier 2 program to claim the referral element.
