Please take part in 2022 Pharmacy Advice Audit

Community pharmacy contractors and their teams are being asked to take part in PSNC's latest Pharmacy Advice Audit in w/c 31st January 2022. The audit will once again ask pharmacy teams to record information about the informal healthcare advice that they are giving over the course of a single day (or until a minimum number of consultations is reached), with the results providing a critical temperature check on how people are continuing to rely on community pharmacies.

This is third Advice Audit that pharmacies have been asked to take part in, and the results will once again provide critical evidence for use in our funding discussions with HM Government and the NHS. Learn more about the 2022 audit.

Community pharmacy contractors requiring additional stocks of LFD test kits for their pharmacies can request up to three additional cartons of test kits. This order is in addition to the one carton daily order allowance that contractors can place through Alliance Healthcare. Orders will be dealt with on a first come, first served basis. Emollients and Flammable warnings

The CCG have asked primary care to be reminded to advise patients who use these products not to smoke or go near naked flames, and warn about the easy ignition of clothing, bedding, dressings, and other fabric that have dried residue of an emollient product on them. Raising awareness: ambulatory BP monitoring over the transdermal patch and opioid overdose

We wish to raise awareness of the potential harm of placing a BP monitoring cuff over the top of a transdermal patch as an opioid overdose occurred attributed to wearing an ABPM. The use of ambulatory BP monitoring through the hypertensive case finding service is now commonly used and as the use of strong opioids in patch formulation is becoming more common the chance of a similar event occurring is obvious. Face coverings

Following the Government's announcement earlier this week that from January 27th, face coverings will no longer be mandatory in public places, pharmacy teams are reminded that the UK Health Security Agency's (UKHSA's) infection prevention control (IPC) guidance will continue to apply to patients and staff in healthcare settings, including community pharmacy, to ensure that everyone is protected.

National consultation termination of pregnancy services

The national survey to assess healthcare practitioners' views will be running over the next few months. Sites, where all eligible staff will be asked to complete a short questionnaire, have been randomly identified to ensure representation across England, Scotland, and Wales. The proposed decriminalisation and demedicalisation of abortion will have significant implications for all methods of delivery and care, and for health care practitioners' roles in administering and supporting abortion procedures.
