Lateral Flow Test availability: Update for pharmacy teams

PSNC has been in urgent discussions with the UK Health Security Agency (UKHSA) about the availability of NHS Test and Trace Lateral Flow Devices (LFDs) to pharmacies.

The UKHSA have confirmed that there are plenty of stocks available in the country, and that they have now activated contingency measures to support the supply of tests to pharmacies. Unfortunately, they are unable to lift the cap of one carton per pharmacy per day due to logistical limitations in the distribution system for the test kits.

Pharmacies should continue to order stock from Alliance Healthcare using the following PIP code: **PIP: 8943995** '**DHSC ORIENT GENE test kits'**. If a pharmacy is getting an out-of-stock message from Alliance Healthcare, it is best to try again the next morning as systems will be updated as soon as that day's UKHSA stock arrives.

LFT - Orient Gene and MYS claiming issues

Contractors have highlighted problems when trying to enter Orient Gene lateral flow device test kits onto the Manage Your Service (MYS) application. Contractors with affected stock will need to add the letter 'G' in front of the lot number to submit their data.

Pharmacy Quality Scheme 2021-2022

PSNC has reached agreement with NHS England and NHS Improvement (NHSE&I) and the Department of Health and Social Care (DHSC) on several measures to help ease the immediate pressures on community pharmacies. Recognising the challenges that pharmacies are currently facing and the contribution of the pharmacy workforce to the COVID-19 vaccination programme, it has been agreed that:

- There will be an extension to the deadline for meeting the requirements of the Pharmacy Quality Scheme (PQS) in line with last year's arrangements.
- Contractors will not be required to complete the Community Pharmacy Patient Questionnaire (CPPQ) for 2021/2022.
- The requirement for pharmacy teams to complete a national audit (intended to be on valproate) in 2021/22 will be waived; and
- The requirement for pharmacy teams to complete a contractor-chosen clinical audit in 2021/22 will be waived.

Pharmacies are still required to make the PQS declaration during the February window, but as last year, this will be a claim for work to be undertaken and evidenced by

30th June 2022. Further details will be published shortly as a Drug Tariff determination on the NHS Business Services Authority (NHSBSA) website with similar wording to last year. PSNC, NHSE&I and DHSC have also agreed to keep the situation under ongoing review. These measures are not all that PSNC requested from NHSE&I and DHSC, but they are the majority, and they are pleased that NHSE&I and DHSC have committed to keeping the situation under review.

PCN Domain

Please ensure you have engaged with your PCN lead and completed the engagement element of the domain. To meet this criterion the pharmacy must have submitted the Flu contractor survey and have attended a webinar or call with lead.

If you do not engage with your lead your pharmacy will be excluded from claiming the PCN domain. The deadline for engagement is the 31st of December 2021.

Do The Right Thing Campaign

It will then be included on the Commissioner's soon to launch 'Safe Space Sussex' app which will direct those at risk to available safe spaces nearby.

Deployment of COVID-19 treatments for highest risk non-hospitalised patients

New COVID-19 treatments will be available for use for patients at highest risk in the community from 16 December. The four UK nations have announced information on providing neutralising monoclonal antibodies (nMABs) or antiviral treatments for the highest risk non-hospitalised patients with COVID-19 which can be found here. Alongside these new routine treatments, the Government has announced details of 'PANORAMIC' – a national study to review the effectiveness of antivirals in a wider at risk patient cohort.
