New CP COVID-19 Vaccination Enhanced Service Specifications for autumn/winter 2022

Further to the publication of the NHSE&I system letter of 22 June 2022 [here], NHSE&I have now published the new draft Enhanced Service Specifications (ES) for Community Pharmacy Contractors for the period from 1 September 2022 to 30 March 2023 (phase 5). For the Community Pharmacy specification please see here. Please read the service specification alongside the letter of 30 June and guidance to support the Community Pharmacy site selection process here.

All pharmacy contractors that are currently commissioned to provide COVID-19 vaccinations under the Phase 3 LES, including "paused" sites, that wish for their designated site to continue to deliver COVID-19 vaccinations from September 2022 should express an interest before 5pm on 14 July. Pharmacy contractors that are not currently commissioned but wish to participate in phase 5 should express an interest by 5pm on 20 July via the webform here. An abbreviated form can be used if the pharmacy contractor has submitted information previously that remains relevant and appropriate. Services will be commissioned where there is a local population need, where pharmacy contractors can meet the key selection criteria and where NHS England considers the pharmacy contractor is best placed to meet that need.

Community pharmacist survey on the delivery of advice and information to patients relating to diet, nutrition and supplementation

My name is Michael Wakeman; I am a pharmacist, currently undertaking a Professional Doctorate at the University of Sunderland through my research project investigating involvement of community pharmacists in providing nutrition guidance to patients.

You are invited to participate in a questionnaire that will acquire anonymised data relating to the level of engagement of community pharmacists in the delivery of advice and information to patients relating to diet, nutrition and supplementation.

Funding opportunity for Independent Prescriber training (for Pharmacists in Primary Care including Community Pharmacy).

As part of the <u>Pharmacy Integration Programme 2021-24</u>, NHS England and NHS Improvement is funding independent prescribing training from early 2022 for pharmacists contributing to primary care, including community pharmacy clinical services.

All programmes include a minimum of 26 days of teaching and learning activities, the structure and delivery of these vary between different providers. In addition to this, each pharmacist must successfully complete at least 12 days (90 hours) of learning in a practice environment where they develop their clinical, diagnostic and prescribing skills under the supervision of other healthcare professionals. Nutricia are currently experiencing low stocks of some flavours of oral nutritional supplements, particularly Fortisip Compact and Fortisip Compact Protein. Stocks vary by depot, below is the stock position as of 28/06/22:

• Green – good stocks, most depots should have this flavour.

- Amber low stocks, expect some depots to be out of stock of this flavour
- Red very low stocks expect several local depots to be out of stock of this flavour

At present "berry" flavours are particularly low stock. If patients report they only want strawberry flavour, please consider contacting their GP to ensure oral nutritional supplements are still required, and if they are request a prescription of Altraplen Compact Strawberry flavour.

NHS Community Pharmacy Smoking Cessation Service Webinar Tuesday 12th July 2022 at 7pm

NHS England and NHS Improvement is hosting a one-hour webinar about the NHS Community Pharmacy Smoking Cessation Service for community pharmacists and their teams, NHS trusts tobacco dependence leads and regional leads, on Tuesday 12th July 2022 at 7pm.

The community pharmacy service launched in March 2022 to provide ongoing support to patients with their stop smoking journey when they are referred to community pharmacy after discharge from hospital. As hospitals set up their in-house smoking cessation service, pharmacies can mobilise to be able to receive referrals. It complements existing local authority commissioned smoking cessation services, creating capacity in the system. The session will provide more details about the service, support with implementation for acute trusts and top tips and lessons learned from those already offering the service.
