New Account Identifier Document for submission of paper prescriptions	Pharmacy Income	Complete by 5th August 2022	From August 2022 (for July 2022 prescriptions), contractors will no longer need to print and submit a paper copy of their completed FP34C declaration. Instead, the NHS Business Services Authority (NHSBSA) will post out a paper Account Identifier Document to pharmacies, along with the usual red separators and pharmacy address labels each month. <u>Find out more.</u>

Contractors must also ensure they verify and, where necessary, update the information contained in <b>each page</b> of the DoS at least once each quarter of the financial year.
