New Account Identifier Document for submission of paper prescriptions	Pharmacy Income	Complete by 5th August 2022	From August 2022 (for July 2022 prescriptions), contractors will no longer need to print and submit a paper copy of their completed FP34C declaration. Instead, the NHS Business Services Authority (NHSBSA) will post out a paper Account Identifier Document to pharmacies, along with the usual red separators and pharmacy address labels each month. Find out more.	
Flu vaccination service 2021/22	Pharmacy Income	Complete by 31 st August 2022	Contractors should not administer any further vaccinations under this service after the 31 st of March 2022. Claims will be accepted by the NHSBSA using the MYS application within six months of administration of the vaccination or by 31st August 2022 , whichever date is earlier, in accordance with the usual Drug Tariff claims process.	
DOS pharmacy hours	Contractual Requirement	Complete by 30 th September 2022	Pharmacy contractors must ensure there is a comprehensive and accurate profile for their pharmacy in the Directory of Services (DoS). Contractors must also ensure they verify and, where necessary, update the information contained in each page of the DoS at least once each quarter of the financial year. The financial quarters are: <ul style="list-style-type: none"> • 1st April to 30th June • 1st July to 30th September • 1st October to 31st December • 1st January to 31st March Reminder of the new NHS Profile Manager tool for updating DoS & NHS website	
NHS Website profile	Contractual Requirement	Complete by 30 th September 2022	Ensure the NHS.uk website pharmacy profile is comprehensive and accurate. Verify and, where necessary, update the information contained in the profile at least once each quarter. The financial quarters are: <ul style="list-style-type: none"> • 1st April to 30th June • 1st July to 30th September • 1st October to 31st December • 1st January to 31st March Reminder of the new NHS Profile Manager tool for updating DoS & NHS website
