

Let's maximise our income by ensuring that all services delivered are claimed. Utilise the pharmacy team to delegate claiming activities and set reminders.

Hypertensive case finding Advanced Service

This service must be manually entered and claimed on MYS monthly.

PharmOutcomes have provided a template on their system for all contractors to use, this will be added for all pharmacies who are currently live on MYS.

For new pharmacies signing up to the service on MYS there will be a short delay of accreditation on PharmOutcomes. The template is spilt into 3 sections: Hypertension case finding (AS), ABPM Fitting and ABPM Follow up.

Discharge Medicine Service

DMS is an essential service so pharmacies must provide this.

Once the referral has been completed in PharmOutcomes you will have to manually input this data into MYS. A training webinar can be found here.

It is important when transferring data that the hospital code is entered correctly. A report can be downloaded in PharmOutcomes to support this task.

Top Tips for delivering services

- Engage with the LPC for support
- Plan a date to complete the required training
- Nominate a champion in your pharmacy who will lead on services
- Create a folder for Locums so they can deliver services
- Promote the services
- Reach out to Public Health leads
- There are 8 Advanced services: Appliance Use Review, CPCS, Flu Vaccinations, Hep C Testing, NMS, Smoking Cessation Hypertensive Case Finding, and Stoma Appliance Customisation.
- NHS Sussex (formally CCG): Gluten Free, MAR Charts, H Pylori (these services are only in certain areas) and Palliative Care

 NHS Surrey (formally CCG): H Pylori, Frimley Only- Simple UTI and Ondansetron
