LPC News

NHS Flu Vaccination Service

This year's NHS flu vaccination service started on the 1st of September.

A reminder that the following categories of healthcare staff for example, care home staff are included in the NHS service.

Frontline health and social care workers - Health and social care staff, employed by a registered residential care/nursing home or registered domiciliary care provider, who are directly involved in the care of vulnerable patients/clients who are at increased risk from exposure to influenza. Vulnerable means those patients/clients in a clinical risk group for flu or who are aged 65 years and over.

Hospice workers - Health and care staff, employed by a voluntary managed hospice provider, who are directly involved in the care of vulnerable patients/clients who are at increased risk from exposure to influenza.

Workers employed through direct payments and/or personal health budgets to deliver domiciliary care - Health and social care workers employed through direct payments and/or personal health budgets to deliver domiciliary care to patients and service users.

Pharmacy staff: Booking your autumn C-19 booster

NHS England has announced that from Wednesday 7th September 2022, around 7 million people (including those aged 75 and over, people who are immunosuppressed, and health and care workers) will be able to book an appointment for their COVID-19 booster vaccinations online or by calling 119.

From Wednesday, health and care workers, including pharmacy staff, can book their COVID-19 booster vaccinations through the National Booking Service. Eligible staff are encouraged to book an appointment for a booster dose as soon as possible, provided it has been at least three months since their last dose of the vaccine. Find out more.

Medicine Shortages

As pharmacies are dealing with the significant number of medicine shortages, there is an ask from GP surgeries that when an item is unavailable and a new prescription is required, could you let them know which alternative medicine is still in stock and available for the patient. The surgeries are aware that at the moment this can change at short notice but want to avoid where possible prescribing another product which is also out of stock.

Hypertensive case finding service and promoting Know Your Numbers! Week 5-11 September

This week is know your numbers week, please use this opportunity to link the hypertensive case finding service and locally commissioned services with this campaign in order to screen eligible patients. More information can be found here.

Become a Pressure Partner

- Promote home blood pressure monitoring (HBPM) by encouraging purchase or signposting to GP surgery for BP@Home.
- Offer guidance on how to use a monitor properly and what to do if the reading is high.
- Offer the BP clinic check if eligible and if required ABPM.
- Direct people Blood Pressure UK website and helpline where they can find all sorts of information about choosing a home monitor, how to use it, and how to look after their blood pressure.
- Patients may not be able to get a blood pressure check in all pharmacies, but
 patients still need help and guidance from you and shared decision making
 on their treatment and medicine adherence. You have a vital role in offering
 this support, you can signpost to pharmacies in your PCN offering the
 hypertensive case finding service.
- Talk about the risks of high blood pressure such as heart disease, stroke, and dementia, and reinforce the healthy lifestyle message, namely the role of healthy eating and physical activity.
- Use your HLP champion and HLP board to promote the campaign.

Surrey Locally Commissioned Services

Each year we review the amounts paid for Public Health Agreement services with colleagues at the LPC. As this year for the first time the Public Health grant was

Community Pharmacy Dental Factsheets

The Health Education England (HEE) teams across London and the South East have collaborated to produce a series of dental factsheets specifically for community pharmacy teams. Obtaining Prolia (denosumab) injection

In recent weeks the Fracture Liaison Service in East Sussex Healthcare NHS Trust have had several messages from GP surgeries querying if there is an issue with obtaining Prolia.

The service has liaised with Amgen to resolve this, they have stated there are no supply issues currently, but they have changed wholesaler to AAH. The letter here

from Amgen explains what to do should the Community Pharmacy not already have an AAH account.

MHRA issues nebuliser warning to pharmacists and parents

Pharmacists should discourage parents from purchasing home-use nebuliser devices for children with asthma, the MHRA has said. In a statement, the watchdog said using nebulisers to deliver asthma rescue medication to children and adolescents without medical supervision "can mask a deterioration in the underlying disease" and potentially cause delays in seeking medical attention.

"Only specialists in asthma should initiate and clinically manage use of nebulisers and associated nebulised medicines at home for acute treatment of asthma in children and adolescents," it said. The MHRA said it was aware of "a number of fatal cases" between 2008 and 2022 in which the clinically unsupervised use of a nebuliser may have contributed to a child's death from asthma.

They have reviewed evidence from paediatricians, respiratory specialists and medicines and medical devices safety experts, adding that the product information for nebuliser asthma solutions has been updated to clarify that the unsupervised home use of nebulisers is not recommended.

The MHRA advised parents: "Only use a nebuliser device recommended by a doctor and ask for training from your asthma nurse, pharmacist, or other healthcare professional on how it should be used and maintained and when to seek medical advice."

NICE clinical guidance states that should only be used under strict medical supervision in severe or life-threatening exacerbations of paediatric asthma or in patients with severe asthma who cannot use other inhaler devices. Any suspected adverse incidents involving nebulisers should be reported via the Yellow Card scheme, the MHRA stressed.

Alison Warren is Consultant Pharmacist in Cardiology, Sussex CCGs and UHSussex and a member of the BIHS EPWP.

The content includes the GP Network Contract DES Specification which includes new requirements for the delivery of a cardiovascular disease (CVD) prevention and diagnosis service by primary care networks (PCNs), with a focus on hypertension in line with the NICE Hypertension guidelines 2019 The LPC has provided content on the hypertensive case finding service to support collaborative working.
