Sexual Health Services update

Surrey County Council Public Health Team went through a procurement to refresh the sexual health services across Surrey. Central and North West London Foundation Trust (CNWL) was the successful bidder to continue the service delivery.

- Many clinical services remain the same across 3 main clinics and 5 spokes
 Sexual Health (STI) Clinics for London and Surrey | CNWL Sexual Health Services
- The CNWL outreach training offer is expanding
- They are developing a clinical network to bring together professionals across the system to share best practice
- Improvement to outreach offer
 - o Online provision Online contraception 18yrs +
 - Online STI testing 16yrs +

Surrey County Council Public health Team is currently carrying out pharmacy visits to distribute promotional material and support the sexual health services we commission.

- Free EHC has been expanded to be available for over 25yrs at the pharmacist discretion
- Chlamydia screening programme offer must now include testing AND treatment
- The condom distribution scheme is being piloting in some pharmacies as distribution points.

PQS

To support contractors with PQS PSNC has launched a workbook that can be used to record activity and provides examples of suggested evidence that contractors can use to confirm you have the necessary evidence ready to make the PQS declaration. The workbook can be downloaded here.

In order to meet the gateway criteria contractors will need to have completed a minimum of 20 NMS between 1st April 2022 and end of 31st March 2023. More information on providing the NMS service can be found here.

Royal Society for Public Health – Preventing and reducing violence in community pharmacy

The Royal Society for Public Health is working with NHS England to ask staff working across healthcare settings in Sussex, for their views in relation to preventing and reducing violence. This will help to design a new national training offer, which will be rolled out during 2023.

They would really appreciate if colleagues working in **any community pharmacy or healthcare setting in Sussex**, would consider taking five minutes to complete their <u>short survey</u>, which will help them to better understand:

Highlighting the dangers associated with using Paraben based skin creams

There have been a number of concerns related to smoking and skin creams in the last 10 years and certain skin conditions such as eczema, pyrosis etc. can lead to risk of fire if people use the creams regularly and do not change their beddings, clothes etc. and wash them at a high temperature, then the paraffin residue can soak into the fabric, making it flammable. More information can be found here.

- Advise patients that if you use creams such as E45, Epaderm cream etc. to be careful around candles
- Patients should be washing bedding at least 60 degrees as well as clothing
- The fire service can offer fire retardant bedding includes sheets, pillows, duvets and fire-retardant lap blankets
- Make people aware of the benefits of stopping smoking if they do use these
 paraffin-based skin creams offer advice around this, open days, public
 events to link in with stopping smoking, display with the creams that can help
 etc.

Brighton and Hove - National recycling week, can your pharmacy help?

NHS Sussex would like to share the poster here with community pharmacies within the Brighton and Hove area. It describes details of a very worthwhile initiative (run by BHCC and NHS Sussex) that is happening during National Recycling Week (17-23 October) where locations across Brighton and Hove will be taking unwanted walking aids (crutches, sticks, frames) to be cleaned up and recycled or reused.
