CPD Peer Review Event

NMS Quarterly Reports

NHS England has confirmed, in its **primary care bulletin**, that community pharmacy contractors are **not** required to submit their completed New Medicine Service (NMS) quarterly summary data to the NHS Business Services Authority for July to September 2022 (Quarter 2), as this requirement has been postponed again. PSNC is pressing NHS England for a review of this data requirement and for early confirmation for contractors on a decision regarding reporting for quarters 3 and 4 in 2022/23.

Change of Pharmacy Supplementary Opening hours

For a pharmacy to change their supplementary opening hours the following amendments to the NHS requirements are now in place from the 1st of October:

- If a contractor wants to increase supplementary hours at the pharmacy this
 can be done with no notice but notification of the change must be given to
 NHSE.
- If a contractor wants to decrease supplementary hours at the pharmacy, 5 weeks' notice must be given.

These replace the previous 90 days' notice requirement.

Novo Nordisk PenCycle recycling scheme

Novo Nordisk have launched their <u>PenCycle recycling scheme</u> to reduce plastic devices entering UK landfills by up to 1.1 million in the next year. To help with this cause community pharmacies can <u>sign-up</u> and participate in this initiative to recycle empty pens, used for diabetes and weight management, in partnership with Novo Nordisk and other partners. This scheme is completely free and all materials will be provided for you free of charge by Alliance Healthcare. Metolazone tablets - Caution needed when dispensing

Metolazone 2.5 mg tablets are only available as an unlicensed product for any prescriptions requesting 2.5mg tablets. However, for the metolazone 5mg strength there is now a new licensed product available called Xaqua – if a prescription has been written generically for the 5mg strength please check with the prescriber which product is required as the new licensed product has a bioavailability twice that of the unlicensed medication, Zaroxoyln. A dose change may be needed when changing from the unlicensed product to the new licensed product. If the unlicensed product is required a new prescription by Brand name would need to be generated.
