Urgent Reminder - NHSE CPAF long version – deadline 4<sup>th</sup> of December Around 50 pharmacies across CPSS received the long version of the CPAF to complete. The e-mail was sent to the pharmacies shared NHS email address. Please remember that this needs to be submitted by Sunday the 4<sup>th</sup> of December.

From those submissions a short-list of pharmacies who will receive a followup visit will be selected. If you do not submit by the deadline the pharmacy will be chosen for a visit.

# Reminder Pharmacy Vision: First chance to share views

PSNC has launched an open consultation to hear from contractors, LPCs and others about their views on the future of the sector. The consultation – which takes the form of an online survey – is the first opportunity within PSNC's vision project for individuals and organisations to share their thoughts with Nuffield Trust and The King's Fund.

The survey is happening in addition to an extensive programme of research,

interviews and initial meetings of the vision Steering Group, Advisory Panel, and Working Groups, all of which have contractors, LPCs and other representatives of the sector at their heart. #### **Sussex Integrated Trainee Pharmacist Programme**

The Sussex Integrated Trainee Pharmacist Programme is a programme of virtual, monthly training events for trainee pharmacists working within primary and secondary care in Sussex and parts of Surrey. This is applicable for those undertaking a short duration placement or a split-sector programme in another sector. The programme aims to promote a culture of multi-sectoral working, supporting the safe transfer of medicines across primary and secondary care, improving patient safety, and being aware of the role of pharmacy in other sectors. The programme has incorporated the Sussex Medicines Optimisation priorities which are:

- Dependence forming medicines (DFM)
- Antimicrobial stewardship (AMS)
- Lipid management in Diabetes for secondary prevention of cardiovascular disease (CVD)
- Low value medicines self-care prescribing (LVM)

#### Sussex infant formula prescribing guidance.

NHS Sussex are pleased to share with you the updated specialist infant formula prescribing guidance. This <u>guidance</u> has been agreed for use across NHS Sussex, and is available on the Brighton & Hove, Crawley, Horsham and Mid Sussex, Coastal West Sussex, and East Sussex formularies.

#### The update aims to:

- Provide more advice to help support continued breastfeeding
- Give easy access to information and resources about Infant Feeding and Specialist Infant Formula
- Help ensure guidance and care is consistent across the whole of Sussex

#### There are three documents available:

- 1. Guidance for prescribing specialist infant formula for cow's milk allergy
- 2. <u>Guidance for prescribing high energy formula for faltering growth and pre-term</u> formula
- 3. Guidance for specialist infant formula and thickening powder available to purchase OTC

As well as additional resources to help with the management of cow's milk allergy in infants.
