#### **Sussex Palliative Care Payments**

There has been a payment issue with the Sussex Palliative Care service, where some contractors have not received reimbursement of up to £1850 in outstanding payments from the commissioner, dating back as far as 2020/2021.

We would sincerely like to thank all those Sussex contractors who have continued delivering the Palliative Care service in good faith for the benefit of our communities and for your patience whilst we investigated and tried to resolve the situation.

Our Deputy Chief Officer Marie has worked very hard over the last 6 months to identify and recover all monies owed to contractors, and we are pleased to report that Sussex ICB have now paid out a total of £48,100 with a further £59,200 in progress to be paid in the next couple of weeks directly to those pharmacies who were affected.

A fantastic result for our pharmacy teams and a big thanks and well done to Marie!
