### Pharmacy Pressures Survey: Please take part.

PSNC has launched a Pharmacy Pressures Survey, and CPSS is asking local pharmacy business owners and staff members to take part.

Community pharmacy owners and teams in Surrey and Sussex are facing unprecedented financial and operational challenges. Alongside the national pharmacy bodies, CPSS is working hard to raise awareness of the severity of the problems to policy makers and lobby for action to ease the pressures. The 2023 Pharmacy Pressures Survey will help to inform this work.

The survey results will be critical to help show Government and the NHS how difficult things now are for pharmacies, and to persuade them to take action. PSNC will be using the results both in negotiations and in national media work as part of the **joint #saveourpharmacies campaign**. CPSS and local pharmacy teams will also be able to use them in our own conversations with local MPs.

As last year, there are two separate surveys, one for pharmacy business owners/head office representatives, and the other for pharmacy teams. Many of the questions are similar to last year – this will give a clear comparison of how much things have worsened since last year.

The surveys will be open for completion until **COP Monday 20th February** and **should take around 15 minutes to complete**.

HEE Placement resources have been developed to support placement implementation in Community pharmacy, GP practice and Hospital.

### **CPPE Newly Qualified Pharmacist Pathway for Community Pharmacy**

The CPPE Newly Qualified Pharmacist Programme registration is now open **until 13th March 2023**. The programme will begin on 27 March 2023.

The aim of the HEE CPPE Newly Qualified Pharmacist Programme is to support newly qualified pharmacists to develop and demonstrate confidence and competence in core areas of pharmacy practice. Pharmacists will be allocated a designated CPPE education supervisor, who will review progress in practice, and provide feedback and support that will develop the learner's confidence and competence to deliver high-quality pharmacy services.

The programme is mapped to the <u>Royal Pharmaceutical Society Post-registration</u> foundation pharmacist curriculum learning outcomes designed to develop prescribing competence. It does not include an independent prescribing qualification, but the programme will help develop the relevant skills and competence needed to prepare for a prescribing course.

The programme is for pharmacists employed (except Boots) or locuming in community pharmacy who have registered with the GPhC since 2020. Pharmacists who registered before 2020 and are returning from a career break or changing sectors are also eligible to apply.

### **Brighton & Hove Workplace Health and Wellbeing Innovation Fund 2023**

Deadline for applications: Monday 27th February 2023 5pm.

The fund aims to improve the health and wellbeing of those working in the City by raising awareness and providing opportunities for workplaces to pilot health promoting initiatives that will lead to the development of a healthier workforce. The funding will address one or all of the below:

Promoting mental health/emotional health & wellbeing/building resilience

Promoting physical activity (including active travel)

Promoting healthy eating

Supporting musculoskeletal health

Tackles isolation and promotes team building

### How much funding can a business apply for?

The innovation fund provides businesses and charities in the city with the opportunity to apply for up to a maximum of £500 to pilot a workplace health & wellbeing programme that aims to address one or more of the above themes.

#### Up to:

£200 for small workplaces = up to 49 employees £300 for medium workplaces = 51 - 250 employees £400 for large workplaces = 251 - 500 employees £500 for large workplaces = 500+ employees

*Note:* This can be match funded by other funding streams or can subsidise activities for staff.

### Who is eligible to apply?

The fund is open to any workplace in Brighton & Hove. If there are a large number of applications workplaces that did not receive funding in 2022 may be prioritised.

### How do I apply?

Complete the application form attached providing as much information as possible and return it to: workplacehealth@brighton-hove.gov.uk.

If your application is successful and you receive funding the money must be spent in accordance with what is stated on your application. The only thing that we require

from you is that you monitor and evaluate the programme and provide a summary of the impact the funding made.

Deadline for applications: Monday 27th February 2023 5pm.
