NMS Quarterly Returns	Voluntary	Complete by the 19 th March 2023	NHS England want to re-start collection of the quarterly returns to provide baseline data to support a long-term evaluation that will be conducted as part of ongoing work to expand the scope of NMS.	
			PSNC have agreed with NHS England that the quarterly returns will initially be on a voluntary basis, with Q3 (October to December 2022) as the first quarter to be reported. PSNC has also agreed a longer than usual submission period over which submissions can be made.

Pharmacy Quality Scheme (PQS) EoL Drugs	Pharmacy Income	Update by 11.59pm on 31st March 2023 if applicable	PQS: NHS Profile Manager can be updated if the pharmacy routinely holds the 16 palliative and end of life critical medicines listed in the PQS Drug Tariff Determination (if contractors are not a stockholder of these 16 palliative and end of life critical medicines, they are not required to update NHS Profile Manager).

Pharmacy Quality Scheme (PQS)	Pharmacy Income	Claim from 9am on 6th February 2023 and 11.59pm on 3rd March 2023	To qualify for the Pharmacy Quality Scheme (PQS) 2022/23 payment, pharmacy contractors will have to meet all the gateway criteria by the end of 31st March 2023. Pharmacy contractors must claim payment for the PQS 2022/23 during the declaration period, which is between 9am on 6th February 2023 and 11.59pm on 3rd March 2023.	
Mandatory Valproate Audit	Contractual Requirement	Start at the latest by the 17 th February. Complete by 31st March 2023	PSNC and NHS England have agreed that the 2022/23 national clinical audit will focus on valproate, with the aim of reducing the potential harm caused by taking valproate during pregnancy. The audit must be completed by all community pharmacy contractors as this is part of their NHS contractual requirements.
