### No mandatory clinical audits in 2023/24

Community pharmacy contractors are **not required** to undertake a contractorchosen or an NHS England determined clinical audit in 2023/24. This follows PSNC's request to remove this clinical governance requirement for contractors in 2023/24. A clinical audit on anticoagulants is included in the Pharmacy Quality Scheme (PQS) 2023/24. If contractors choose to not participate in PQS, and therefore do not complete the anticoagulant clinical audit, there is still no requirement to complete two clinical audits in 2023/24.

# Urgent treatment centres and emergency departments can now refer patients to community pharmacists

Urgent treatment centres and emergency departments can now start <u>to refer</u> <u>patients for a consultation with a community pharmacist for a minor illness symptom or</u> <u>for an urgent supply of a regular medicine</u>, using an IT solution which meets the minimum digital requirements of the service (as specified within the <u>NHS CPCS</u> <u>Technical Toolkit</u>).

#### **CPCS Claims**

From **1st June 2023** in a change from the previous service specification, claims for payment should be submitted within one month of, and no later than three months from, the claim period for the chargeable activity period.

## Did you know patients can self-refer via NHS 111 online

## How NHS 111 online works:

People can visit <u>111.nhs.uk</u>, enter their age, sex, postcode and main symptom and are then asked a series of questions about their health problem, the patient is triaged.

They can:

- find out how to get the right healthcare in their area, including whether they need to see a GP or seek urgent care.
- get advice on self-care.
- referral to a pharmacy for an urgent supply of medication.
- get a call back from a nurse, doctor or other trained health professional if they need it.

## Surrey Heartlands ICB – change in preferred diabetic meters

Surrey Heartlands ICB are starting a project where we are asking pharma partners Neon Diagnostics and GlucoRx to support practices to switch their high cost meters to the lowest cost meters. As a consequence of this you may see changes in patients prescriptions for their diabetic test strips to fit these companies meters and you may want to review your stock holdings.
