Last few days to complete the 2023/24 CPAF screening questionnaire.

The CPAF screening questionnaire has been completed by 73% of community pharmacies. The remaining pharmacies have a limited amount of time left to complete it before the deadline of **midnight this Sunday**, **30th July 2023**.

We strongly recommend that pharmacy owners who have not yet had the chance to complete the questionnaire do so as soon as possible. It should take approximately 10-20 minutes to complete.

Training

Community Pharmacy PCN Lead training event

The first Community Pharmacy PCN Lead training event was held on the 25th July for leads across Surrey and Sussex. The event launched the new Community Pharmacy PCN Lead service across NHS Sussex and NHS Surrey Heartlands and was run by the excellent Captivating Solutions.

The workshop covered a range of topics, including the evolution of the PCN Lead role, strategic time management, building relationships with key stakeholders, and effective communication.

The PCN Leads of Surrey and Sussex said they left the workshop feeling empowered and equipped with the tools they need to drive integration with primary care and help their fellow community pharmacies find capacity for new services.

We look forward to starting this new service to support the integration of community pharmacies and GP Practices at a local level.

National shortage of GLP-1 receptor agonists – Reminder do not recommend brand or strength Rx switches

We've had reports from some GP practices that community pharmacies are suggesting that patients request different strengths or brands of GLP-1 agents. This message does not align to the medicine supply notification from DHSC earlier this month. Please remind all pharmacy team staff of the alert as below.

A CAS alert was published on 18th July with instructions/recommendations for all clinicians that are involved in this shortage (see here) (CAS-ViewAlert (mhra.gov.uk)).

Non-steroidal anti-inflammatory drugs (NSAIDs): potential risks following prolonged use after 20 weeks of pregnancy

A reminder that systemic (oral and injectable) NSAIDs such as ibuprofen, naproxen, and diclofenac are contraindicated during the last trimester (after 28 weeks) of pregnancy due to the risk of premature closure of the ductus arteriosus and renal dysfunction in the foetus and due to prolongation of maternal bleeding time and inhibition of uterine contractions during labour.

Please advise patients who are pregnant to avoid use of NSAIDs available without prescription from week 20 of pregnancy onwards unless advised by their healthcare professional.

Surrey Heartlands has launched Children and Young People's Asthma Toolkits to help healthcare staff and families to understand more about asthma, to know how it is treated and to improve outcomes for children and young people.

The new Toolkits for healthcare professionals provide specific guidance and advice to health professionals working all sectors across Surrey. They provide information on a wide range of topics including understanding the preschool wheeze, how to make a diagnosis, pharmacological treatment, how to conduct an asthma review and training resources. Meanwhile, the Toolkit for Families has been enhanced to explain to children, young people, parents and carers what asthma is with easy to follow videos, details on what to do during and after an asthma attack, and tips on triggers and prevention.
