### Westminster Hall Debate on the Future of Community Pharmacies, Thursday 14<sup>th</sup> September

CPSS wrote to all the MP's across Surrey and Sussex this week to ask for their support by attending a Westminster Hall debate on the future of community pharmacies.

The debate is very timely as it is likely to coincide with the launch of the <u>Vision</u> for community pharmacy, which is being developed by The King's Fund and Nuffield Trust on behalf of Community Pharmacy England.



# **Training**

### Community pharmacy technician: advancing your role

This new NHS England fully funded training programme will help pharmacy technicians develop the skills and confidence to deliver effective clinical services in

community pharmacy. This is to ensure that they have the right post-registration training to enable confident, safe working practices and career development. Launching in September, up to 840 pharmacy technicians will be able to apply for the training.

**Duration and delivery mode:** This is a 4-month self-directed e-course consisting of six modules, with approximately 4-6 hours of learning per week. The training programme is delivered online and also includes one face to face workshop on clinical assessment skills, facilitated by CPPE.

**Who can apply:** You will need to follow the CPPE application process and confirm that you:

- are a registered community pharmacy technician
- have access to a pharmacist or other health care professional in practice who is able to observe and sign off your clinical assessment skills practice
- will provide the postcode of your place of work
- will agree to attend one of the mandatory clinical assessment skills face-toface workshops and one online peer reflection workshop to guarantee your place and gain access to the e-course.

The programme launches on 28 September and <u>registration is open now</u>.

The workshop is a face to face event and it will provide an excellent opportunity to network with other pharmacy professionals, and a chance to reconnect with friends and acquaintances. A light buffet will be served before the workshop from 6:30pm.

This is a hands-on workshop to allow healthcare professionals to familiarise with a variety of inhaler devices and other aids and to practice delivering support to people to optimise their inhaler technique. All healthcare professionals who come into contact with people who are using inhalers should be able to check inhaler technique and provide advice to improve the use of inhaled medicines. This workshop will develop knowledge, skills and confidence to support patients to improve their outcomes and have an impact on the quality of life for people with COPD and asthma.

### **CPPE** Preparing to train as an independent prescriber

CPPE are pleased to announce the launch of their new learning programme, *Preparing to train as an independent prescriber*. This programme aims to build the confidence and competence of pharmacists who are planning to apply and train as independent prescribers and is open to all pharmacists, who are planning to commence their independent prescriber training with a Higher Education Institute (HEI).

The course is made up of four main components, including a self-directed e-course and self-assessment framework, a mandatory online workshop to support you to review your self-assessment of competencies, an optional online workshop to support your readiness for academic writing and reflective practice, and optional peer support sessions, providing the opportunity for you to develop your professional network and establish communities of practice. Its aim is to help pharmacists prepare an application and prepare themselves for prescribing training by helping them to understand what it means to be a prescriber, considerations when choosing a course, how they can demonstrate relevant knowledge and skills and plan for the study and supervised practice requirements of the course.

**Preparing to train as an independent prescriber** is scheduled to launch on 12 September and you can find information about it on the CPPE website: www.cppe.ac.uk/career/preparingtotrainip.
