Local Services

Sussex Prescription Ordering Direct (POD) service transition

From the 29th of September 2023, patients will not be able to order repeat prescriptions using the NHS Sussex POD telephone or text service. Responsibility for repeat prescribing is being transferred back to individual GP practices.

Patients who use the POD service are being contacted directly with details of how they can continue to receive their repeat prescriptions via their GP practice.

NHS Sussex do not anticipate this change to impact on community pharmacies, however a letter has been sent to pharmacies in the surrounding areas to share useful information when interacting with patients or if you receive any enquiries. Funding to support expansion of pharmacy technician workforce

NHS England Workforce, Training and Education (WT&E) directorate are offering funding to support the training of pre-registration trainee pharmacy technicians (PTPTs) on a multi-sector training programme, or single sector Community Pharmacy only training programme. The Pharmacy South East team will be holding two 90-minute webinars to provide further details regarding this funding opportunity. Please register to attend one of the webinars using the link below (you do not need to attend both sessions).

- 1. Thursday 3 August 2023, 10am
- 2. Thursday 3 August 2023, 7pm

How much funding is available?

- £46,099 per PTPT over the 2-year training period.
- Funding is intended to contribute to the cost of developing and running a twoyear work-based training programme.

• It is recommended education costs are covered through apprenticeship levy.

What do I need to do to be eligible for funding?

- Identify you are able to provide educational supervision from a GPhC registered pharmacy professional throughout the full 24-month training programme.
- Complete a short on-line expression of interest with an overview of your proposed training programme. This will be used to shortlist allocation of funding. (The link to the expression of interest will be circulated after the launch webinar, and will open for applications on Monday 7th August)
- For organisations wishing to deliver a multi-sector programme, have formed a
 partnership that includes a minimum of two healthcare settings, at least one of
 which must be responsible for delivery of day-to-day patient facing pharmacy
 services.

What support is provided by NHS England WT&E?

- Initial Q&A sessions for each Integrated Care System with the NHS England
 WT&E Pharmacy Technician Lead and dedicated programme facilitator, to help answer any questions and help build networking opportunities for multi sector partnerships.
- Support from a dedicated pharmacy programme facilitator to offer guidance and expertise throughout the 2-year training period.
- Employer network meetings to share experience, practice and resources.
- A range of resources including examples of job adverts and learning plans shared by existing training placements.

NHS Surrey Heartlands change in blood glucose test strip formulary

The two meters from this formulary which will be suitable for **most ADULT patients** with **TYPE 2 diabetes** are GlucoRx Q and Finetest Lite Smart. GP Practices have been asked to speak to their local pharmacy and inform them of the preferred meter test

strips that they will be prescribing so that pharmacies are aware. You may see the following prescribed in preference to other products as these blood glucose meters become used by increasing numbers of patients.

- GlucoRx® Carepoint lancets
- GlucoRx® pen needles

2. Neon Diagnostics:

- Finetest Lite® test strips
- Greenlan® lancets
- o Greenfine® pen needles
