Training



Recruitment of Trainee Pharmacists for 2025/26 via Oriel - Introduction to the process and support sessions

For the 2025/26 foundation training programme, all training sites will be required to recruit their trainee pharmacist(s) via the National Recruitment Scheme. This is managed using the UK wide online portal called Oriel. The national recruitment cycle for trainee pharmacists starting their foundation training in 2025 begins in January 2024 and closes in March 2024.

The 2025/26 foundation training programme will see also the introduction of the requirement that all training sites must be able to provide access to a Designated Prescribing Practitioner (DPP) and a prescribing learning environment. More information about these changes is available here.

To support you in preparation for 2025/26 foundation training, the NHS England WT&E South East pharmacy team are hosting three online webinars in November 2023 to discuss what this means for you as employers. The focus of these webinars will be on the recruitment of trainees via the Oriel National Recruitment Scheme. These webinars will be followed up by support sessions throughout January and February 2024, when the window for employers to enter their programme into Oriel is open.

Reminder - Full pack dispensing of valproate-containing medicines

Changes to the Human Medicines Regulations 2023 on the 11th of October, implemented new rules requiring pharmacists to dispense all licensed medicines containing valproate in the manufacturer's original full pack.

Pharmacies must supply valproate products as complete packs and should not repackage them in plain dispensing packaging. However, exceptions can be made based on individual risk assessments, allowing pharmacists to supply valproate-containing medicines in different packaging as long as patient information leaflets are provided.

Additionally, all licensed medicines containing valproate have been reclassified as special containers for reimbursement purposes, with pharmacies being automatically paid for the relevant number of complete packs. The Medicines and Healthcare products Regulatory Agency (MHRA) has also released new guidance to support this change. Further information is available here.

ADHD Medication shortages – guidance from NHS Surrey Heartlands



There are currently supply disruptions affecting various medications which are licensed for the treatment of attention deficit hyperactivity disorder (ADHD). A national patient safety alert has been issued here. NHS Surrey Heartlands have been advised that centrally NHSE are looking at publishing further guidance but until this is

published they have been working with colleagues from Surrey & Borders Partnership NHS Trust to produce a pack which provides useful information and clinical recommendations about how to manage these shortages. Please see here.
