MPs invited to Parliamentary event on Winter Pressures

This week Community Pharmacy England invited MPs from all political parties to attend a Parliamentary drop-in event on winter pressures to learn more about community pharmacy.

The event in Westminster will be a chance to brief MPs about the current winter pressures and to talk about the critical role that community pharmacies play in supporting their local communities and healthcare colleagues throughout winter.

This discussion will also emphasize that the sector needs fair and proper funding to enable these new services to be delivered in the long term and that pharmacies also need help to manage the worsening medicines supply situation.

The event will take place in Portcullis House on December the 5th.

The pharmacies selected will be notified via email from the NHS Business Services Authority in the week prior to the golive date. The full version of the CPAF questionnaire, which may be helpful to view before starting to complete it, will be available on the <u>NHS Business Services Authority (NHSBSA)</u> website.

Call for pharmacies to sign up for the Surrey Pilot condom distribution service (CDS)

The pilot condom distribution service (CDS) is commissioned by Surrey County Council under a memorandum of understanding, only pharmacies that are already delivering Emergency Contraception and Chlamydia Testing and Treatment can sign up to deliver this service.

The pharmacies will be condom distribution outlets once a C-Card has been issued by a registration outlet in order to supply condoms etc. As distribution outlets pharmacies enable convenient access to the young people and the aim is to increase the use of the service.

The pharmacy will be paid \pounds 4.13 for each supply and a single retainer fee of \pounds 50 (for attending training etc)

The service compliments existing sexual health services that the pharmacies are commissioned to provide. The key aims of the scheme are to:

• reduce the number of unintended teenage conceptions.

• reduce the incidence of HIV and other STI's in young people.

• increase the availability, accessibility, and acceptability of condoms.

 reduce the associated barriers in accessing condoms, including financial cost (leading to health inequalities) and embarrassment.

• link individuals into mainstream services.

Important Information regarding the HLP locally commissioned service that includes the Alcohol Identification and Brief Intervention service.

Due to the recent issues in accessing some of the training sessions that supports this service, the team has revised the training requirements outlined in the specification to ensure pharmacies can start to deliver the service. This was a Public Health error and they apologise for any inconvenience caused.

Pharmacy teams can begin to deliver the service once they

have completed the <u>20 minute E-learning module</u> available via NHS England. Please complete this training at your earliest opportunity and remember to claim your training payment of £20 via PharmOutcomes.

Pharmacy teams are then required to complete the commissioned Alcohol Brief Intervention training (2 hours) within 3/6 months. A link will be shared shortly with the details of this training session.

To support delivery of this service, pharmacies will be sent Audit C scratch cards and some further health promotion materials.

Remember to record your conversations on PharmaOutcomes and claim £10.
