### Condom Distribution Locally commissioned service Surrey



Surrey County Council has commissioned a pilot service where young people can get free condoms at a number of outlets across Surrey via the Condom Distribution Service.

It is a free and confidential condom distribution network for people aged 13- 24 years old in Surrey. The C-Card scheme aims to ensure easy access to sexual health advice and free condoms for young people and has proved a successful element of strategies to reduce unprotected sex, rates of STIs and unplanned pregnancies.

Young people remain the age group most at risk of STIs in England. C-Card schemes are an effective way to help young people take responsibility for their sexual health; providing them with ease access to free contraception, education about sexual health and wellbeing, and are an opportunity to signpost to local services. This service is commissioned under a memorandum of understanding to enable pharmacies to hand out condoms to registered patients. ### NHS Sussex Community Pharmacy Emergency Palliative/End of Life Care (EOLC) Locally Commissioned Service (LCS)

NHS Sussex have recommissioned the community pharmacy EOLC LCS. This LCS was originally set up in 2020 to improve patient access to EOLC medicines across Sussex when they are required in an emergency. This was achieved by ensuring sufficient coverage by community pharmacies in each Primary Care Network (PCN).

NHS Sussex have reviewed the coverage in each PCN and we

now have 76 community pharmacies signed up to provide this LCS. These pharmacies stock a locally agreed range and quantity of EOLC medicines to ensure that users of this service will have prompt access to these medicines. Where the community pharmacy is unable to fill the entire prescription, the pharmacy team should support the patient to find/signpost to another community pharmacy who is able to fulfil the prescription where appropriate.

Please note, many community pharmacies now hold a range of palliative/EOLC medicines. In the first instance prescriptions should be presented at the patients local/nominated community pharmacy. ### Reminder: Gateway Criteria - Advanced Services – New Medicine Service (NMS)

Contractors must have delivered a minimum of 15 NMS between the 1st of April 2023 and **by the end of the 31st of December 2023.** Further information for contractors who open or change ownership from the 1st of June 2023 is



#### detailed in the Drug Tariff.

Contractors will not be required to make a declaration for this gateway criterion as this will be verified by a post payment review of the contractor's NMS payment data between the1st of April 2023 and by the end of the 31st of December 2023 held by the NHS Business Services Authority – contractors must ensure all NMS are claimed by the end of the 5th of January 2024.

Contractors should note that they will not be able to claim payment for the quality criteria during the declaration period if the gateway criterion has not been met.
