CPPE have recently launched a new programme, Community

For Sussex Pharmacies: Sussex ICS Scoping Survey to Identify pharmacies who plan to or are interested in hosting Trainee Pharmacists (TPs) either as a lead employer or multi-sector rotation site in 2025/26.



The General Pharmaceutical Council (GPhC) published new learning outcomes and Standards for the Initial Education and Training of Pharmacists, incorporating independent prescribing (IP) within MPharm and foundation pharmacist training year (FTY), meaning pharmacists registering in 2026 will be IP at point of first registration.

The 2025/26 FTY (starting July 2025) is the first year TPs will be assessed against the full learning outcomes, including IP. Funding for each site employing TPs in 2025/26 FTY is £26,500 per TP.

Funding will be:

- Consistent across all sectors of practice and regions of England
- 2. A contribution to all costs of hosting a TP, including supervision, administration, and salary costs.

Benefits hosting TPs:

TPs will be able to input into clinical and non-clinical activities under appropriate supervision and:

- Respond to medication queries, complete medicines
 reconciliation and undertake medication reviews
- Conduct patient consultations
- Monitor ongoing treatment and make recommendations
- Promote health and make every contact count.
- Complete quality improvement project audit cycle

Fresubin 2kcal and Fresubin 2kcal Fibre stock issues – advice from Surrey Heartlands ICB

There are currently intermittent stock issues with some flavours of Fresubin 2kcal and Fresubin 2kcal fibre oral nutritional supplements. Both supplements have a **BLUE** traffic light status in Surrey Heartlands and should only be prescribed on the advice of a dietitian.

As of 15/12/2023 Fresubin 2kcal is in stock to wholesalers in Vanilla flavour only, and Fresubin 2kcal fibre in Chocolate and Neutral flavours only.

Prescribers are being advised to switch patients from Fresubin

2kcal and Fresubin 2kcal fibre on to AYMES 2.0kcal where products are not available, suggested flavour switches are in the table below.

Patients receiving Fresubin 2kcal/ 2kcal fibre for use through an enteral feeding tube should only be swapped to a suitable alternative on the advice of a dietitian.

Pancreatic enzyme discontinuation and supply issues – advice from Surrey Heartlands ICB



The ongoing national issues with pancreatic enzymes continue.

Pancrease HL has been discontinued.

Nutrizym 22 capsules will be out of stock from mid-

December 2023 to end of January 2024.

Creon 25,000 capsules availability is still sporadic.

During December 2023 and January 2024 if Creon 25,000 is unavailable Creon 10,000 can be prescribed, but prescribers and patients should be aware the dose needs to be increased by 2.5. (So, if a patient takes 2 x Creon 25,000 with a meal, they will need to take 5 x Creon 10,000).

The supply issues are causing patients significant anxiety. Unfortunately, the specialist HPB team at the Royal Surrey have had several anecdotal reports of patients being told that all pancreatic enzyme products are being discontinued. Please do reassure patients that the supply issues are temporary.
