Pharmacy First	Pharmacy Income	Complete by 11.59pm on 31st January 2024	Deadline for pharmacy owners to declare that they agree to the terms and scope of the three elements of the Pharmacy First service and therefore claim the £2,000 initial fixed payment; <b>this will be paid on 1st March 2024</b> . Note this will be reclaimed if pharmacy owners do not provide five clinical pathways consultations by the end of March 2024. Pharmacy owners can still declare that they agree to the terms and scope of the three elements of the Pharmacy First Service after this date, but they will not be entitled to the £2,000 initial fixed payment.	
CPCS	Pharmacy Income	1 <sup>st</sup> February 2024	Pharmacy owners providing CPCS, who have not declared that they agree to the terms and scope of the three elements of the Pharmacy First service will be de-registered from providing CPCS (and will be notified of this).	
Pharmacy First	Pharmacy Income	Complete by 29 <sup>th</sup> February 2024	A minimum of one Pharmacy First clinical pathway consultation will need to be completed to reach the minimum required for the monthly payment.	
Pharmacy Contraceptive Service	Pharmacy Income	Complete by 29th February 2024	Contractors who have <b>previously registered</b> to deliver the current Tier 1 NHS Pharmacy Contraception Service <b>on or before 30</b> <b>November 2023</b> , must opt-in to the new extended service via the Manage Your Service (MYS) system, <b>by 29 February 2024</b> .	
Pharmacy Quality Scheme	Pharmacy Income	Claim between 9am on 5th February 2024 and 11.59pm on 1st March 2024	The funding will be divided between qualifying pharmacies based on the number of points they have achieved up to a maximum £137.50 per point. Each point will have a minimum value of £68.75, based on all pharmacy contractors achieving maximum points. Payments will be made to eligible contractors depending on the band they are placed in, how many domains they	

			have declared they are meeting, and hence points
