- To drive awareness on: Alcohol screening and brief interventions aim to identify current and/ or potential problems with alcohol use and motivate those at risk to change their drinking behaviours.
- Overview of what this training course covers.
- Define & explore key messages around alcohol in the context of your role.
- Recognise the importance of brief interventions and of addressing barriers to behaviour change.
- Explain the link between alcohol and a range of health issues and the benefits to drinking within the guidelines.
- Practice using a screening tool and delivery of simple brief advice & interventions.
- Identify when & how to refer to specialist services.

NHS Surrey Heartlands – funded IP places support

As you are probably aware, NHSE (formerly Health Education England) has been funding commissioned Independent Prescriber training courses for eligible pharmacists from Autumn 2022 to March 2024, after which a national re-procurement of IP courses will be taking place. We are aware that several commissioned universities are now fully subscribed, and that several pharmacists have been struggling to access a funded IP course.

NHS Surrey Heartlands ICB – Emergency Alert Cascade messages

Following on from the Alert Cascade Exercise before

Christmas the system is now going live and will only be used



to alert pharmacies to incidents which may impact their services.

The alert will be cascaded to the pharmacy contact numbers via text to voice speech and will provide an initial summary of the incident. A copy of the incident alert will also be sent to the pharmacies email/inbox and the message can also be acknowledged from there. It is important that the incident alert is acknowledged as it provides confirmation that you have received it.

Thank you for all your support with this project, being able to reach out to you at the point of incident will make a massive difference to how Surrey Heartlands ICB is able to respond to incidents and the actions they take.
