For Brighton & Hove pharmacies only: Healthy Living Pharmacies Training Update A recording of the Delivering effective Alcohol Screening and Brief Intervention Training is now available on Brighton and Hove County Council Learning Zone. Please note this session is only available for GP and Pharmacy teams.

Overview

This alcohol training video will help professionals identify individuals whose drinking might be negatively impacting their health and to be able to deliver simple, structured, brief interventions.

Duration

90 minutes

Assessment

There is a short assessment to complete after watching the video.

Learning Outcomes

By the end of this course, you will be able to:

- Define and explain key messages around alcohol in the context of your role.
- Recognise the importance of brief interventions and of addressing barriers to behaviour change.
- Explain the link between alcohol and a range of health issues and the benefits to drinking within the guidelines.
- Practice using a screening tool.
- Identify when and how to refer to specialist services.
- Practice delivery of a simple brief advice and interventions.
- Know where to get further resources.

The Public Health Team have organised an <u>online training day</u> for practice staff and pharmacists who are signed up to the Public Health Agreement for NHS Health Checks.

This session is aimed at those who will be delivering the NHS Health Checks to patients in community pharmacy and other locations. It will include an explanation of the tests that are included in the NHS health check. It will give delegates confidence in assessing risk, communication of risk and suggestion of actions to help patients reduce their risk of CVD and diabetes. This session is also suitable for those who have not delivered NHS Health Checks since the pandemic and wish to refresh their memory before resuming services. To maximise learning from the day, it is recommended that the OnClick 'Health Check Mentor' e-Learning module is completed prior to attending this session. Community Pharmacy Surrey & Sussex and NHS Sussex Webinar – helping people with severe mental illness attend physical health checks Tuesday, 19th March 7pm to 8pm

People with schizophrenia, bipolar disorder or other psychosis (severe mental illness) face a shorter life expectancy by an average of 15-20 years, mostly due to deaths from cardiovascular disease, but also from COPD and liver disease. We know that for many people with severe mental illness, their local pharmacist is a familiar and trusted individual who can advise on health matters. Join our next webinar for a discussion about how you can directly help to improve health outcomes for this vulnerable group of people, by sharing information and reassurance with them about booking and attending an annual physical health check with their GP Practice.

Dr. Lindsay Hadley FRCGP, NHS Sussex lead for physical health checks for people with severe mental illness, will lead the session that will cover why people with severe mental illness have such poor health outcomes and how the health check can make a difference. She will also talk through how to spot signs of worsening mental health and what to do about it.

New Independent Prescribing (IP) supervision resource for prospective Designated Prescribing Practitioners (DPPs), employers and system leaders

NHS England have launched a new multi-professional resource for clinicians considering becoming a DPP and employers and system leaders aiming to support DPP capacity in their workforce, particularly the pharmacy workforce.

The resource consists of a suite of web pages, frameworks, real-life examples and Frequently Asked Questions (FAQs). It also includes information for prospective DPPs from professions other than pharmacy, wishing to support a pharmacist IP learner.

The resource aims to reduce barriers to the DPP role by ensuring those eligible understand the role, its expectations and where to find advice and training.

NHS England - Shortest Effective Course Lengths for antibiotics – amoxicillin key messages

What is the problem with current courses of antibiotics?

- Unnecessarily long courses of antimicrobials are one of the factors driving antimicrobial resistance and an increased risk of Clostridioides difficile infection in at-risk populations.
- Antibiotic course durations have often been based on a seemingly arbitrary and weak evidential basis. With antimicrobial resistance recognised as a global threat to public health, reducing course lengths when the evidence demonstrates that this not only does no harm but is potentially safer for the patient.
- "Each additional day of antibiotic therapy is associated with a 4% increase in risk of side effects and a 3% increase in risk of resistance" [Curran J 2022].

Antimicrobials should only be used when they confer health benefits, in other words when the risk benefit ratio falls in favour of treatment.
