Pharmacy Pressures Survey 2024: Community Pharmacy England wants to hear from you.

Community Pharmacy England's third annual Pressures Survey is underway, and your contribution is crucial. Community Pharmacy Surrey & Sussex hopes that local pharmacy business owners and staff members across the region will be able to take part, and we're keen for even more voices from across the sector to be heard.

The survey allows you to share your experiences on pressing issues such as medicines supply issues, workforce concerns, workload, stress levels, patient demand, and other impacts on your pharmacy. Every contribution is important in building up the strongest possible picture of the challenges you are facing.

The more responses submitted, the better that Community Pharmacy England can measure the pressure the whole sector is under for use in negotiations, conversations with MPs, and the national media. Your responses will help push the Government and NHS to improve the situation.

The survey is expected to take just 10-15 minutes of your time and is open until **23.59 on Tuesday 2nd April.**

now eligible for COVID-19 treatments. In line with these recommendations, NHS England is expanding access to LFD testing from 1 April 2024 for:

• people aged 85 years and over

• people with end-stage heart failure who have a long-term ventricular assistance device

people on the organ transplant waiting list

people aged 70 years and over, or who have a BMI of 35 kg/m2 or more, diabetes or heart failure, and: – are resident in a care home, or – are already hospitalised

For Sussex Pharmacies only: Training for people providing a take-home naloxone service

Naloxone is a drug that can reverse the effects of opioids. Anyone can use naloxone in an emergency. You don't need to be a doctor or medical professional. The course covers recognising and responding to an opioid overdose, and how to use naloxone to potentially save someone's life.

Once you complete the training and pass the quiz, you will get a certificate. Please download a copy of your certificate, as you will need it to get a naloxone kit.

Reminder - Translation and Interpretation Services

Translation and Interpretation services are provided to community pharmacies via their Integrated Care System.

NHS Surrey Heartlands

Translation and Interpretation services are available via telephone, remote video platform and when appropriate face to face. The current provider is thebigword. In order for an account to be set up for the community pharmacy with thebigword, a Data Processing Agreement (DPA) needs to be completed. Once this is done, instructions are sent on how to access the Translating and Interpreting services and a fully signed version of the Data Processing Agreement returned to the pharmacy. Fresubin 3.2kcal temporary supply issues – Information from Surrey Heartlands ICB

3 flavours of Fresubin 3.2kcal are currently out of stock (Cappuccino, Hazelnut, Mango) with Vanilla remaining in stock.

Prescribers are being advised that if Fresubin 3.2kcal is unavailable patients should be prescribed Altraplen Compact Daily. This can be taken as 50ml x 5 per day if patients prefer to take their supplements in small volumes.

Fresubin range temporary discontinuations.

Due to increases in demand and pressures on supply chains Fresenius Kabi have been experiencing supply challenges with some of their 200ml oral nutritional supplements.

In order to optimise production capacity and optimise product availability some flavours have been temporarily discontinued until the end of 2024:
