Pharmacy First	Pharmacy Income	Complete by 11.59pm on 31st March 2024	Deadline for pharmacy owners to have delivered a minimum of five Pharmacy First – clinical pathway consultations that cross the Gateway point.  If pharmacy owners have not delivered a minimum of five of these consultations by this date, they will have their £2,000 initial fixed payment recovered.	
Hypertension Case–Finding Service	Pharmacy Income	Complete by 31st March 2024	Contractors can start working towards achieving their incentive fee for 2023/24 (need to provide 20 ABPMs between 1st of April 2023 and 31st of March 2024 to achieve the incentive fee).	
NHS Profile Manager	Contractual Requirement	Complete by 31st March 2024	Ensure the DoS and NHS.uk website pharmacy profile is comprehensive and accurate by updating via the NHS Profile Manager.
