Hastings and St Leonard's PCN: TLHC Pilot service Community Pharmacy NHS
Smoking Cessation Service Support for Targeted Lung Health Check Service

A fantastic opportunity to sign up for a new pilot service: Targeted Lung Health Checks, this project is currently underway in PCNs within Brighton however, due to its success we are now moving to **Hastings and St Leonards PCN in May**. As part of this service patients are asked about their smoking status and offered cessation support referred via NHS Mail to a pharmacy signed up for the pilot.

This pilot service dovetails onto the advanced national smoking cessation

service. For this pilot a patient is referred directly from the targeted lung health check clinician into a pharmacy signed up to the service. You must have capacity to deliver, a validated CO monitor, have met training requirements outlined in spec, commit to attend the training webinar on the 23rd of April on Teams at 7pm and be ready to receive patients via an electronic referral and submit result back to via a consultation tool.

As this is a pilot there will be a selection process based on national service sign up, geographical locations and access for patients.

Anyone who wants to provide this service will need to attend the webinar. Please see your pharmacy email inbox for the Teams invite and further information.

For Brighton & Hove pharmacies only: Healthy Living Pharmacies Training Update

A recording of the Delivering effective Alcohol Screening and Brief Intervention Training is now available on BHCC learning Zone.

Overview

This alcohol training video will help professionals identify individuals whose drinking might be negatively impacting their health and to be able to deliver simple, structured, brief interventions.

Duration

90 minutes

Assessment

There is a short assessment to complete after watching the video.

Learning Outcomes

By the end of this course you will be able to:

- Define and explain key messages around alcohol in the context of your role
- Recognise the importance of brief interventions and of addressing barriers to behaviour change.
- Explain the link between alcohol and a range of health issues and the benefits to drinking within the guidelines
- Practice using a screening tool
- Identify when and how to refer to specialist services
- Practice delivery of a simple brief advice and interventions
- Know where to get further resources.
