# Learn from patient safety events (LFPSE)

As part of the clinical governance provisions in the Terms of Service, contractors must report patient safety incidents to the NHS.

LFPSE reporting was introduced in 2021 (replacing the National Reporting and Learning Service) and contractors should now use this system for reporting patient safety incidents. Reports are made via the LFPSE website.
