Pharmacy First Thresholds: Share Your Views

Community Pharmacy England wants to hear opinions from pharmacy owners in Surrey and Sussex on Pharmacy First thresholds.

A short survey is gathering pharmacy owners' views on increases in Pharmacy First thresholds and the effects of GP action. The results will contribute to the national negotiator's ongoing efforts to raise awareness of pharmacy pressures and push for increased core funding.

The ten-minute survey, open until **11.59pm on Monday 26th August**, offers local pharmacy owners the chance to feed directly into Community Pharmacy England's work. **Read more here**.

## **Local Services**



LFD service promotional resources

CPE have resources to help pharmacy owners and teams promote the Lateral Flow Device (LFD) service to people aged 85 and over, as well as care home residents.

- **Seniors 85+:** Pharmacy teams are encouraged to proactively speak with these individuals and their carers about keeping a box of LFD test kits at home. Pharmacies can attach small promotional flyers to prescription bags as a reminder to check their test kit supply.
- Care Home Residents: Residents aged 70 and over, those with high BMI, diabetes, or heart failure, are also eligible to receive free LFD test kits. Care home staff, however, can only access the service if they meet the criteria themselves. Pharmacies can email or send letters to care homes, informing them about the availability of the LFD test kits.

### **Frimley ICB Place Engagement Leads**

There is an opportunity for up to five community pharmacy professionals (Note: you do not need to be a registered pharmacist of pharmacy technician to do this role) to work with Frimley ICB community pharmacy integration team as a Community Pharmacy Primary Care Network engagement lead.

The community pharmacy primary care network (PCN) engagement lead role has been established to support the local implementation of the pharmacy <u>Primary</u> <u>Care Access Recovery Plan (PCARP) requirements</u>, including implementing the

Pharmacy First Service and expanding the Blood Pressure Checks Service and Pharmacy Contraception Service.

The role will help develop channels of engagement between community pharmacy and PCNs and build partnership that supports integrated clinical pathways for patients. The community pharmacy PCN engagement lead role is being funded by NHS England until 31 March 2025. The expectation is that the role will function as a point of contact for local community pharmacies and for general practices in the PCN.

Community Pharmacy leads will be expected to carry out their role on one day per calendar month with **a payment of £400 per day**. We are hoping the role will start from Sept 2024. There will be one lead role for each place (Bracknell Forest/ North East Hampshire and Farnham/ Royal Borough of Windsor and Maidenhead/ Slough/ Surrey Heath). Please indicate on the MS form, which Place you will be applying for. Please note the deadline for submission is **26th August 2024**.

### #AskAboutAsthma returns for its eighth year in September 2024.

The <u>campaign</u> encourages simple changes to children and young people's care that will make a big difference to how they experience their asthma.

The cross-sector campaign focuses on helping children and young people with asthma to live their best lives. Asthma should not limit children and young people's lives in any way. Good asthma control means having **no** symptoms.

#AskAboutAsthma promotes these four asks:

- 1. get an asthma action plan in place.
- 2. understand how to use inhalers correctly.
- 3. schedule an asthma review every year and after every attack.
- 4. consider air pollution and its impact on lung health every asthma conversation should include indoor and outdoor air pollution.
