### Epsom Hospital will go live with DMS referrals this week!

You will have seen an increase in DMS referrals from Ashford and St Peters hospital and the Royal Surrey hospital. This is to inform you that **Epsom hospital will now also be sending DMS referrals out to community pharmacies from this week.**

### Valproate update

Men taking valproate and their partners are being advised by the Medicines and Healthcare products Regulatory Agency (MHRA) to use effective contraception because of new data suggesting a potential small increased risk of harm to children if valproate is used by a father at conception.

MHRA have published a <u>Drug Safety Update</u>, which includes information and advice for healthcare professionals and patients.

### Surrey Heartlands ICB message - Fresubin 3.2kcal shortage

There is a current shortage of Fresubin 3.2kcal oral nutritional supplements, which is anticipated to continue until early November. The suggested alternative product for patients prescribed Fresubin 3.2kcal is Fresubin Pro Compact, please see the below table for nutritional comparison and flavour availability.
