FP10 dressing prescriptions changes across some areas in Sussex ICB

Please be aware that Sussex ICB are looking to change the way that dressings are provided to patients across Sussex ICB this is to align the whole of Sussex with the same process. Currently there are different procedures in place across many of the areas. Below is the latest update from the ICB – we would encourage you to review any dressings that you hold in stock in light of the proposed changes.

The ONPOS community pharmacy supply route in Brighton and Hove ceased on 7th October with a move to obtaining dressings from NHS Supplies. Notification was provided to these contractors prior to the end of the service to support them to reduce any stock holding.

The plans are to roll out the remainder of the new Sussex supply route in the areas where your contractors are currently dispensing FP10 prescriptions for wound care items.

In the High Weald Lewes Havens area, community nurses are now ordering via our new direct supply route so the number of FP10s being requested for formulary items will be reducing. From 27 January 2025, the numbers will reduce further over a couple of months as we introduce the new route for all services in this area.

For the rest of East Sussex, and Coastal West Sussex, we will be introducing the new route with a phased approach from 13 January 2025 so the prescriptions for formulary wound care items will start to reduce from this date over a couple of months.

In Crawley, Horsham and Mid-Sussex (North, West Sussex), as there is an existing direct supply service, FP10 numbers are likely to remain the same.

Adrenaline Auto Injectors (AAI) dosing

When reviewing prescriptions for Adrenaline Auto Injectors (AAI), please remember AAIs are prescribed dependent on patients' weight for both adult and paediatric patients.

Surrey Heartlands ICS put together an Aide Memoire for GPs on prescribing AAI. This can be found here. This aide memoire can also be used by colleagues in community pharmacy to check patients have been prescribed the correct dose of their AAI.
