The campaigns aim to promote best practices among the public, health workers and policy-makers to reduce its spread. The theme for the World Antimicrobial Awareness Week (WAAW) 2024 is "Educate. Advocate. Act now."

Antimicrobial resistance (AMR) is a pressing global health and socioeconomic crisis and continues to pose a severe threat to modern healthcare, making infections harder to treat and putting our lives at risk. Yet, much more can be done to raise public and stakeholder awareness.

### **NHS Sussex Opioid Conversion Chart**

Caution is needed when switching patients between opioid containing medications. Whilst these medicines can be effective for severe pain, they also pose a significant risk of overdose.

If clinically indicated to switch between opioids then a number of factors must be considered including, but not limited to:

- 1. The potency difference between the opioids in question
- 2. Patients specific needs including pain severity, opioid tolerance and medical history
- 3. Need for robust counselling including the risks and benefits of switching and education on overdose signs and symptoms and when to seek further medical advice
- 4. Need for regular follow-up to assess efficacy and safety

An opioid conversion chart was recently approved by NHS Sussex to guide

prescribers on doses when switching between opioids in palliative care and can be used to support community pharmacy when dispensing prescriptions where a patient has been switched between opioids. The chart can be found <a href="here">here</a>.
