## Central flu procurement and supply - call for provider engagement

The <u>NHS England Vaccination Strategy</u> set an ambition to improve the efficiency and responsiveness of vaccine supply. As part of this, the aim is to explore the potential costs and benefits of centralising the procurement and supply of adult flu vaccine.

NHS England want to hear from providers of the adult flu vaccination service about the current procurement model and how this supports delivery of the flu programme. Providers are invited to complete a <u>questionnaire</u> which takes 15-20 minutes and is anonymous. The deadline for completion is Tuesday **17 December 2024**.



# Independent Chair role required for the Sussex Primary Care Provider Collaborative

Sussex Primary Care Provider Collaborative brings providers of General Practice

and Community Pharmacy across Sussex together with a vision of creating a sustainable and thriving primary care system in Sussex which aligns with the NHS Sussex "Improving Lives Together" mission. As primary care is not one but hundreds of independent organisations we need to work together effectively to achieve this vision, the PCPC Board provides a way of doing that and it is key that we have independent support and oversight in this. Therefore the Board are looking for an independent Chair who has experience of working at Board level within the NHS and understands the value, quality and agility that Primary Care brings.

They estimate that the role would require a minimum of a day per month, renumerated at a rate of £75 per hour. There is likely to be some need to travel to face to face meetings in Sussex.

## **Pharmacy First Patient Survey**

Community Pharmacy England and Healthwatch England have launched an online Pharmacy First patient survey that pharmacy owners can direct patients to after receiving the service.

The aim of this collaboration is to collect patient feedback on the service to help inform service improvements and to help to quantify the value of the service to the public.

Pharmacy teams providing Pharmacy First are asked to help promote the survey using the resources we have developed. To encourage as many responses as possible, the survey has been designed to be quick and easy to complete; during testing, most patients took around two minutes to complete it.

## Why should we ask patients to complete the survey?

Use of the survey is optional, but we encourage pharmacy owners and their teams to consider offering it to patients for several reasons, including:

- Helping to gather important data on patients' experience of using the service;
- Feeding into the national evaluation of the Pharmacy First service, and the results will be shared with the Department of Health and Social Care and NHS England;
- Supporting Community Pharmacy England and Healthwatch England's national work, and local data can be shared with local Healthwatch organisations and Local Pharmaceutical Committees (LPCs) to inform their discussions on the service at a local level; and
- Reinforcing Community Pharmacy England's communications and public affairs work to demonstrate the value of the Pharmacy First service.

The survey will remain open until at least the end of 2025.

## **Surrey Pharmaceutical Needs Assessment**

Surrey Health and Wellbeing Board has produced the first draft of its 2025 Pharmaceutical Needs Assessment (PNA) report. The aim of the Surrey PNA is to describe the current and future need for pharmaceutical services in Surrey. It achieves this by providing an overview of pharmacy services in Surrey (what is provided and where) and makes an assessment around whether what is currently in place meets the needs of residents, both now and in the future.

Reminder emergency supply requested by member of the public
We have been asked us to remind pharmacists of the 5 days supply rules for
schedule 4 and 5 medications. Note this includes co-codamol 30/500mg tablets.

Pharmacists are sometimes called upon by members of the public to make an emergency supply of medicines. The Human Medicines Regulations 2012 allows exemptions from the Prescription Only requirements for emergency supply to be made by a person lawfully conducting a retail pharmacy business provided:

- that the pharmacist has interviewed the person requesting the prescription-only medicine and is satisfied:
- that there is immediate need for the prescription-only medicine and that it is impracticable in the circumstances to obtain a prescription without undue delay;
- that treatment with the prescription-only medicine has on a previous occasion been prescribed for the person requesting it;
- as to the dose that it would be appropriate for the person to take;
- that no greater quantity shall be supplied than will provide 5 days' treatment of phenobarbital, phenobarbital sodium, or Controlled Drugs in Schedules 4 or 5 (doctors, dentists, or nurse prescribers from the European Economic Area and Switzerland, or their patients, cannot request an emergency supply of Controlled Drugs in Schedules 1, 2, or 3, or drugs that do not have a UK marketing authorisation) or 30 days' treatment for other prescription-only medicines, except

when the prescription-only medicine is:

- insulin, an ointment or cream, or a preparation for the relief of asthma in an aerosol dispenser when the smallest pack can be supplied;
- an oral contraceptive when a full cycle may be supplied;
- an antibiotic in liquid form for oral administration when the smallest quantity that will provide a full course of treatment can be supplied;
