#### **Reminder patient referral process back to NHS 111 for Pharmacy First**

Reminder the process has changed for escalating a patient back to NHS 111 when needed following a Pharmacy First referral. Now instead of Starline numbers, just phone 111 and use option 3 for healthcare professionals when prompted.

**Pancreatic Enzyme Replacement Therapy (PERT) shortages information** You will be aware of the difficulties in sourcing PERT highlighted by the Medicines Supply Notification issued 9th May 2024 which was subsequently superseded by the <u>National Patient Safety Alert : Shortage of Pancreatic enzyme replacement</u> <u>therapy (PERT)</u> (recently updated on 12/09/2024).

AS well as availability through a pharmacies usual wholesalers due to this remaining an ongoing issue there has been agreement with the Oxford Pharmacy Store (OPS) (Oxford Pharmacy Store UK specialist wholesaler of pharmaceutical products.: Oxford Pharmacy Store) that they will fulfil orders from Community Pharmacies in Surrey, Sussex and Frimley for stocks of Pangrol (import) where required.

We hope this information is useful in helping you support your patients currently prescribed PERT.

#### **Surrey Heartlands Pharmacy First videos**

There is now available a Pharmacy First peer-to-peer explainer video, which features Dr Amy Blakemore (GP Partner), Ness Shahidi-Giles (Clinical Pharmacist), and Rebeka Waite (Patient Services Advisor) answering FAQs on Pharmacy First.

#### Safeguarding

Safeguarding is the action we take to promote the welfare of adults & children and protect them from harm. Everyone who comes into contact with adults & children at risk of harm has a role to play. Due to recent deaths we have included some information to support your team recognise signs of deterioration so that your team are aware of any signs that a patient may need extra support..

Safeguarding is an emotive subject but having an increased awareness of and knowing what to do when these concerns arise is important, please use this information to complete CPD and refresh your knowledge.

It is important to raise any concerns with your local team and follow your safeguarding policy.

Community Pharmacies see lots of people everyday and many of these will be your regular patients, there are some signs that a regular patient may be deteriorating

• Does the patient have difficulties paying for prescriptions if so remind that about the <u>Prepayment Certificates</u>, <u>potential benefits</u> that could be claimed and dependent on condition eligibility for Medical exemption (via Gp)

- being smelly or dirty
- being hungry or not given money for food

- having unwashed clothes
- having the wrong clothing, such as no warm clothes in winter
- having frequent and untreated nappy rash in infants

#### Children

- aggression or bullying.
- anti-social behaviour, like vandalism.
- anxiety, depression or suicidal thoughts.
- attention seeking.
- constant or regular sickness, like colds, headaches and mouth ulcers.
- drug or alcohol use.
- eating disorders

#### **Adults**

- Physical injuries.
- Clothing worn, or heavy make-up, to cover injuries, for example long sleeves or a scarf in hot weather, or sunglasses inside or when cloudy.
- afraid or anxious to please their partner.
- without access to their own money: for example, not being able to pay by card,
- or trying to use a card in their partner's name.
- withdrawn and unwilling to engage in friendly conversation.
- meek, fearful or extremely apologetic
