# Community Pharmacy leaflet and poster to promote services to the public in Brighton

Marie Hockley, Deputy Chief Officer for Community Pharmacy Surrey and Sussex, has been working with the Trust for Developing Communities (TDC), The Hangleton and Knoll project, and Public Health in Brighton & Hove to create a <u>leaflet</u> and <u>poster</u> that will be shared across the city to promote Community Pharmacy services.

This piece of work was funded by the TDC and developed due to patient feedback

at the Integrated Community Teams meetings, that members of the public and voluntary care organisations didn't know how to access services, what services were available and were confused about Pharmacy First, particularly the seven common conditions and how to identify them. It was important to explain the Pharmacy First seven common conditions to enable patients to walk in and self-refer appropriately, this has therefore been incorporated into the leaflet, so patients are supported to access the healthcare they need.

Information is accurate and remains up to date as the QR codes link directly to the national service finder and public health website to find a pharmacy. QR codes will take patients directly to the list of commissioned pharmacies and postcode finders so they can choose where to access services.

This is a fantastic achievement for our Communities and Community Pharmacies.

We are actively exploring options to secure funding to roll this out in East and West Sussex.



#### **Reminder NMS claim changes**

Ahead of making a claim for the New Medicine Service (NMS) consultations carried

out in April 2025, pharmacy owners are reminded of the changes to the service's payment structure that came into effect this month.

Important guidance documents for people in Police Custody who require supervised Opioid Substitution Therapy (OST)

Surrey police update OST pilot: Go live at 07:00 on Tuesday 6th May at Staines Custody

We have been supporting Surrey Police, Mountain Healthcare and i-Access to create a guidance document which sits alongside the pharmacy supervised consumption SLA that allows medications to be collected by a Police Officer for people who are in police custody. This is to assure you that this is in line with procedures and allows a seamless transfer of supervised medication that is usually given under the direction of the pharmacist.

Please read the guidance document, save to your folders/print out and adjust your SOPs as required, this process will be in place for all people who are detained in custody and require they medication whilst in police custody.

#### Sussex CGL

Sussex CGL have created this guidance to sit alongside the pharmacy service specification that allows medications to be collected by a Police Officer for people who are in police custody, this process is already in place. This is to assure you that this is in line with procedures and allows a seamless transfer of supervised medication that is usually given under the direction of the pharmacist.

## Training



For Frimley ICB pharmacists only - We are pleased to share an exciting opportunity as part of Frimley ICB's plans to launch a local "Teach and Treat" programme. This initiative aims to create a sustainable, scalable model that will increase access to high-quality Independent Prescribing training placements for community pharmacists.

Frimley ICB will be working with four designated Community Pharmacy Hub sites supported by trained Designated Prescribing Practitioners (DPPs) and DPP mentors to facilitate direct patient care, supervision, and mentorship.

Frimley ICB are now inviting pharmacists who are planning to undertake their Independent Prescribing qualification to express their interest in completing their placement at one of our Community Pharmacy Hub sites. Please note:

• **Places will be limited**, and applications will be reviewed to ensure fair allocation based on eligibility and placement availability.

- Final placement offers are dependent on contractual agreements, and timelines may be subject to change.
- Sites are based in Maidenhead & Farnborough
- Our longer-term ambition is to expand this model to additional sites, helping to build a strong and sustainable pipeline of independent prescribers across the Frimley system.

#### **Aspiration Payment**

Pharmacy owners will be able to claim an Aspiration payment if they wish to between **9am on 1st May 2025 and 11.59pm on 16th May 2025**.

Pharmacy owners will need to make a declaration to the NHSBSA using <u>MYS</u> and indicate which domains they intend to achieve before the end of the declaration period. The aspiration payment must be claimed between 9am on 1st May 2025 to 11.59pm on 16th May 2025 for pharmacy owners to receive payment on 1st July 2025.
