

Pharmacy Quality Scheme

PQS is back for 25/26

The 2025/26 scheme began on 1st April 2025 and has a declaration period **between 9am on 2nd February 2026 and 11.59pm on 27th February 2026**. Pharmacy owners must have evidence to demonstrate meeting the domains that they have claimed for **by the end of 31st March 2026**. It has £30 million funding available and pharmacy owners will be able to claim an Aspiration payment if they wish to **between 9am on 1st May 2025 and 11.59pm on 16th May 2025**. 

COVID-19 Vaccination Programme Site Selection Process (Outreach Services) to the South East

NHS England South East is seeking to procure providers who have the capability and capacity to deliver COVID vaccination outreach services. The services additionally will cover enhanced aspects of vaccination awareness, engagement, communications and education.

The core aim of each Lot is to reduce the gap in vaccination uptake by eligible individuals and cohorts within population groups who experience health inequalities, and link population groups and areas of need to preventative healthcare and support.

Vitamin D Supplements on prescription - reminder

It has been reported from care home medication reviews that patients maybe receiving unlicensed vitamin D food supplements, even though licensed products are available. Only licensed colecalciferol products should be prescribed and dispensed. If a licensed product is available in the strength/formulation prescribed, please check this is dispensed.
