#### **MP Community Pharmacy Visit**

Following an invitation to visit a community pharmacy we were pleased to welcome **Tom Rutland MP**, Member of Parliament for East Worthing and Shoreham to Boots Pharmacy in Shoreham on the 23<sup>rd</sup> of May. During the visit he heard from pharmacy team members about the work of community pharmacy including our current challenges and potential future opportunities.

### **Local Services**



#### **Brighton Locally Commissioned Service – Swap to Stop**

Swap to Stop Programme - As you may be aware, the UK Government has launched the Swap to Stop programme, which provides free vape starter kits to adult smokers as part of a national strategy to reduce smoking-related harm.

#### **Brighton & Hove Stop Smoking Team have provided the following key facts:**

Vaping is substantially less harmful than smoking. It is widely supported by public health authorities as a safer alternative for adult smokers who struggle to quit through other means.

Although not without risk vaping poses only a small fraction of the risk of smoking. This is because there is no combustion with vapes and the vapour produced does not contain the harmful chemicals in cigarette smoke that cause respiratory disease, heart disease and cancer. Anyone who smokes and who completely switches to vaping is making a change that results in immediate health benefits. Vaping is one of the most effective Stop Smoking aids. Nicotine vapes are effective cessation aids and are recommended as a first choice stop smoking aid. High-quality randomised controlled trials have found nicotine vapes to be an effective aid to quit smoking. The use of nicotine vapes as a stop smoking aid has been endorsed by NICE, the NCSCT, the British Thoracic Society, the Royal College of General Practitioners, the Royal College of Physicians, the Royal College of Obstetrics and Gynaecology, and the Royal College of Midwives.

The Swap to Stop programme is backed by the UK Government and the NHS. It is designed to support smokers in making a positive change. Pharmacy staff are encouraged to complete the official NCSCT training module to confidently and correctly advise clients.

#### Independent Prescribing courses 2025-26 – NHS England funded training

Applications for NHS England funded independent prescribing courses are open. Courses are available up to March 2026, with several universities offering multiple dates for cohort intakes. Start dates will depend on the university provider.

Pharmacists who meet the eligibility criteria will be able to apply for independent prescribing courses at a variety of universities across England:

1. Community pharmacists (including locum pharmacists)

Eligible pharmacists may apply only to those universities as listed on the <u>NHS</u> <u>England website</u>. They will need to demonstrate (as a minimum):

- The support of an identified designated prescribing practitioner (DPP).
- An appropriate practice-based learning environment in a prescribing setting that can offer appropriate clinical support.
- Evidence that you meet the course provider eligibility criteria (applicants will be subject to their chosen university's enrolment processes).
- Commitment to use the skill within your area of competence and expertise, for the delivery of NHS clinical services as they emerge.

Universities are listed on the <u>NHS England website</u> by sector. Please note: the available universities differ depending on the sector you work in. Course length and the number of face-to-face days required vary between universities. Please check the individual university webpages for further information on course format.

#### Funding

Independent Prescribing training is available to pharmacists who meet the eligibility criteria. Tuition fees are fully funded by NHS England. Pharmacists that are successful in applying to one of the approved universities will be allocated a fully funded place directly by the university. They do not need to apply to NHS England for funding separately.

## PQS



To qualify for a PQS payment, your pharmacy must be registered for both the Pharmacy First and Pharmacy Contraception Services. Contractors must have signed up to deliver the Pharmacy First Service and the Pharmacy Contraception service by the end of 31st August 2025 and remain registered for both services until the end of the scheme, 31st March 2026.

Contractors will **not** be required to make a declaration for this gateway criterion as this will be verified by a post-payment review of the contractor's declaration to deliver the services and subsequent registration from 1st September 2025 until the end of the scheme, 31st March 2026.
