Childrens Flu Vaccination Service	Pharmacy Income	31st August 2025	To help improve flu vaccination uptake for children, NHS England is launching a new flu vaccination service for two and three-year-olds in community pharmacy from 1st October 2025 to 31st March 2026. This is intended to supplement the GP offer. It will be for one year initially, pending the outcomes of an evaluation. Contractors must read the service specification for the full requirements of service delivery and consider if they are able to meet these. Contractors must register to provide this service on MYS. Contractors who register by 31 August will receive vaccine by 1 October 2025. Contractors will be paid £9.58 per vaccine administered.	
Flu Vaccination Service Point of Care system Pharmacy Income possible, prior to the start of the flu service.		possible, prior to the start of the	NHS England has announced the launch of a new community pharmacy Point of Care (PoC) IT Supplier Contractual Framework, which will allow pharmacy owners to choose which PoC system they use to make their clinical records for the Flu and COVID-19 vaccination services during the Autumn/Winter 2025/26 campaign. IT suppliers listed on the new framework have been assured by NHS England as having met specific minimum standards. Pharmacy owners should select an NHS Englandassured IT supplier and contact them directly to set up new accounts.	
Flu Vaccination Service – pregnant women only	Pharmacy Income	1 st September 2025	Pregnant women only, can start to be vaccinated under the 2025/26 Flu Vaccination Service (other eligible patients cannot be vaccinated until 1st October 2025).	
PQS – Antimicrobial Stewardship Audit	Pharmacy Income	1st September 2025	PQS: The Antimicrobial Stewardship – Pharmacy First consultations clinical audit can be started from this date (the 2025/26 clinical audit can be conducted from 1st September 2025, last start date is the 3 rd February to complete no later than 31st March 2026). Pharmacy First monthly payments	Pharmacy Income	From 1 st October 2025	In addition, to being registered to provide Pharmacy First, PCS and HCFS to receive the monthly PF payments, subject to also achieving the relevant volume of clinical pathway consultations, the pharmacy must also deliver at least one Ambulatory Blood Pressure Monitoring (ABPM) provision per month.	
Pharmacy Quality Scheme Claim Period	Pharmacy Income	Between 9am on 2nd February 2026 and 11.59pm on 27th February 2026	The final PQS claim declaration must be made between 9am on 2nd February 2026 and 11.59pm on 27th February 2026.
